Bridal Airbrush Makeup Application (Includes professional false lash application)	\$ 80
Bridal Party Airbrush Makeup Application (Includes professional false lash application)	\$ 63

*If you are having a makeup trial done, please wear clothing that is as close in color as possible to the color of your wedding dress, so that we can ensure that your makeup is correctly matched. Day Of- make sure your face is cleansed and moisturized prior to arrival at the location to ensure that your makeup stays put during the day.

Please note, we highly encourage all brides to STRONGLY suggest to their attendants that they have their makeup done professionally by our team as well. Makeup completes the look and is the perfect final touch. Your wedding pictures will be seen for years and years to come, and the flawless look that is achieved through highlighting and contouring with makeup helps with the flash of the camera. By all means, we want your attendants to feel comfortable with their look, however, this professional touch really goes a long way to ensure that everyone in your pictures looks perfectly polished.

We will recreate the look we achieved during your preview session. Please remember that everyone in your wedding party is welcome to join us for services on your wedding day. Please note that these prices are per person, per service.

WEDDING DAY GUIDELINES

The WildRoots team will prefer to set our timeline, typically starting early in the morning.

We are allowing our staff members to see other clients that day as well.

Please arrive with clean, dry hair to help with the hold of your hairstyle.

An additional fee may apply if you request a wash, blow dry, or straighten.

Terms & Conditions

BOOKINGS: To secure a date, a signed contract and the appropriate deposit are required. Please note that your wedding date will be held on our books for three (3) weeks from the date we email the Bridal Contract to you. If we have not received your contract along with the deposit by that time, we will no longer hold your wedding date and we cannot guarantee our availability to perform your bridal services. The Bridal Services Deposit payment may be made in person or by phone. After receiving said deposit, we will email an itemized Bridal Services Invoice, which will list your remaining balance due. Please note, we can only accept cash or credit cards as payment for your services.

1-3 bridal party members = \$250 deposit
4-7 bridal party members = \$500 deposit
8-11 bridal party members = \$1,000 deposit
12 + bridal party members = \$1,200 deposit

FEES | GRATUITY: To ensure that your day runs flawlessly, there is a Coordinating Booking Fee of \$10 per attendant. A 20% gratuity will also be added for each service. A \$100 studio fee is also required for bridal parties of 5 or more. This room fee allows you to use our studio space for any food or drinks you wish to bring, and it allows a place for you and your bridal party to relax while the others are having their services done.

PAYMENT: The remaining balance of your invoice must be paid at least one (1) week prior to your wedding date. If the remaining balance has not been paid by this date, we reserve the right to not provide bridal services for your wedding. The remaining balance must be paid in one lump sum. No partial payments will be accepted. Your final payment may be made either in person or by phone. If for any reason you need to make any changes or corrections to your invoice, please contact our office as soon as possible. The first invoice revision will be made at no charge; however, subsequent invoice revisions will be \$10 for each revision.

COVID: Due to the uncertainty that Covid can present, we would like to reassure you that we will do everything to help ensure the best experience and outcome possible.

- If plans change on the behalf of the wedding party due to Covid, WildRoots will return all collected pay besides the “coordinating/booking fee of \$10 per attendant”
- If one or two attendees cannot participate due to Covid, that money will not be returned.
- If three or more attendees are unable to participate, we will refund that money for each of their services aside from the booking/coordinating fee.
- If the Wedding needs to be rescheduled, WildRoots will do all we can to accommodate the future wedding date. However, we ask for one week to check in with all independent contractors/staff and their availability. If WildRoots is unavailable for the future wedding date, all money will be refunded aside from “ The original booking coordinating fee for each attendee”.
- If Covid should present itself on one or more of the staff at WildRoots, we will take necessary CDC guideline recommendations. However, if it were only one staff member, we would look to find a replacement and/or ask the bridal party to be willing to work with our committed staff and start earlier.

SOCIAL MEDIA & WEBSITE: Photos taken at the trial or your professional photos may be used as examples of our work for future clients to view. Your photographer will receive proper credit for their work. You agree to WildRoots using these photos, as well as give consent to using your professional photos on our website/portfolio/social media. We will email you to request these photos and will also reach out to your photographer.





Terms & Conditions

SERVICE LOCATION & REQUIREMENTS: The location of makeup and hair styling services for the day-of-event will be at the Bride's discretion, but there are certain requirements the artist will need to complete the services. Stylists will bring all equipment needed for their service to be performed. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly. Please communicate the hotel room number if applicable by email or text.

CANCELLATION POLICY: Your booking is a reserved spot. If for any reason you need to cancel your bridal services after your deposit has been made, a portion of your deposit will be non-refundable. All cancellations must be submitted communicated in written form either by email.

- 6-12 months prior to wedding = 30% non-refundable deposit
- 3-5 months prior to wedding = 40% non-refundable deposit
- 2 months or less = 50% non-refundable deposit

I, _____, agree to the terms set forth in the Bridal Packet. I understand and agree to pay the Bridal Services Deposit in the amount of \$ _____ to secure my wedding date. I also agree to pay the full payment of \$100 for the Event Room rental if bridal services are performed at WildRoots Salon. I understand that the Event Room rental fee is nonrefundable.

I understand that the Bridal Services Deposit must be made within three (3) weeks of receipt of said contract to ensure that my wedding date is reserved, and that the balance of the Bridal Invoice is due one (1) week prior to the date of the wedding. I understand that no refunds will be given for any members of the wedding party who miss their appointment on the day of the wedding. I further understand and agree to the cancellation fees in the event that I need to cancel my wedding day services with WildRoots Salon & Studio.
